The 22nd Annual Cabin Fever Expo, sponsored and run by the Penn's Woods West Chapter of Trout Unlimited, will be held on Sunday March 1st 2020 at the Doubletree by Hilton Pittsburgh – Cranberry in Warrendale, PA. Penn's Woods West Trout Unlimited would like to extend you an invitation to attend the Expo as an exhibitor.

The 2019 Expo was a huge success and had well over 900 attendees during the show. We were also fortunate to have a completely sold out vendor space at the 2020 Expo. The members of Penn's Woods West Trout Unlimited want to thank the 2019 exhibitors for making the Expo a great success this year, and we look forward to working with you in 2020!

The Cabin Fever Expo has:

- Nationally known speakers to draw many attendees to the show
- Over 500 free parking spaces - no paid parking for exhibitors or customers.
- Over 9,000 square feet of unobstructed space on one floor. A diagram of the 2019 Expo layout will be sent out soon.

Our booth cost is the same as last year. Standard 8'x8' booths are \$150 and must be paid in full by February 15, 2020. The same as last year, all booth spaces come with a 6' table and 2 chairs. **Your contract and payment in full are due no later than February 15, 2020.** Please note this date! We cannot guarantee a booth will be available, or that the same booth space as the previous year if your payment is not received by the deadline. Given the fact that we had a "sold out" vendor area last year, I would encourage you to return your payment and contract early to ensure that your space is available for 2020. There will be no payments accepted the day of the event, you must register and pay by the deadline.

The basic requirements for vendor booths have stayed the same – the side walls of your booth may not extend more than 4 feet from the back of the booth. We do understand that some vendors want longer walls to accommodate a particular exhibit. As many exhibitors have booths that do not use side walls at all, it has become a problem to mix booths that use longer side walls and those that don't. The vendors without side walls were concerned about visibility to their customers when placed among the deeper booths. Once again in 2020, we are going to do the following:

- If your booth walls will exceed the four foot limit as per the contract, you must obtain written permission from the PWWTU for the walls. If you have not done this and register at the Expo with booth walls that exceed the contract's limits you will be required to remove the side walls. PLEASE, let us know before you arrive so we can accommodate your request.

- Booths that have side walls that exceed the contract's limit will be grouped together on the show floor. This will result in booths that have longer walls being placed next to other booths with longer walls.

As the aisles have become more congested each year, it is **imperative** that you maintain the front to rear and side to side dimensions of your booth. We will have the aisles clearly marked and ask that vendors cooperate in staying within their booth space for the expo.
