2024 Candidate Statement – ED Barger

I have been a PWWTU board member, and treasurer since 2018. I also serve as a liaison between our chapter and the neighboring Forbes Trail TU chapter, as I live on the boundary between the two chapters.

2024 Candidate Statement - Roger Dice



My name is Roger Dice. I fished for trout with my father and grandfather starting at age 12 using worms we dug up in our vegetable garden. In1982 I "graduated" to fly fishing and joined TU. I've been a Life Member of TU since 1999.

I am a mechanical engineer and have retired from a broad-based career in the design, construction, operation and maintenance of building envelopes and infrastructure. My wife and I have been married for over 53 years and have lived in Allegheny County for most of that period. We travel throughout the US and Europe enjoying retirement after our 40-year careers.

Along with Trout Unlimited, I belong or contribute to The Sierra Club, World Wildlife Fund, National Parks Conservation Association and the National Wildlife Federation.

I have assisted PWWTU with Cabin Fever and the Dunbar Creek cleanup. I also participated in a stream monitoring program to monitor the effect of the Marcellus Shale Gas exploration on local streams in Allegheny County. Along with fishing the streams in Potter County, I helped stock trout in Kettle Creek and the West Branch of Pine Creek. I always clean trash from the streams I fish.

I have come to appreciate the necessity of responsible stream management through my personal experiences and through membership in many conservations organizations, including TU. If I am elected to the PWWTU Board of Directors I plan to help lead our efforts in conservation and environmental stewardship.
